We, the undersigned natural persons of the age of twenty-one years or more, all of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is WOODLAKE PROPERTY OWNER'S ASSOCIATION, SECTION ONE, INC.

ARTICLE TWO

The corporation is a non-profit corporation.

ARTICLE THREE

The period of its duration is perpetual.

ARTICLE FOUR

The purpose or purposes for which the corporation is organized are: To provide civic and social services and assistance for the benefit and betterment of the residents and property owners of the Woodlake Subdivision, Section One, a residential development in Bell County, Texas.


