## **OLD BUSINESS:**

**Possible WPOA name change**: The Board considered a possible name change for the property owners association. There is apparently some difference between the legal, registered name of the Association and the name that is commonly used for Association business. This could call for an Association name change or, a change of certain legal documents, a replacement of one property deed (tennis courts) or, no formal action, at all. A committee was appointed to look into the matter and report back to the Board for a decision.

**Covenant changes**: The Board considered making changes to the three sets of Woodlake restrictive covenants. The primary purpose of the effort is to bring the Architectural Control Committee (ACC) under the authority of the BOD. Other changes to the covenants will also be considered. A committee was appointed to study the issue, propose changes to the covenants, and report back to the Board for a decision.
